Notes:

- The per diem rate for a given resident will be the sum of federal rates for each category. This sum will be subject to the wage adjustment. For presentation and analysis purposes, we have shown the wage adjustment applied to each category separately. Final rates paid may be slightly different due to rounding.
- Non-therapy ancillaries will be paid at 300% for the first three days of a resident's stay.
- Physical and occupational therapies will be paid at 100% for the first 20 days of a resident's stay. From days 21 through 100, these rates will be reduced by 2% for each additional seven days of a resident's stay.
- Residents with a diagnosis of HIV/AIDS will receive an 18% add-on to the nursing component of the PDPM payment.

The Federal rates are based upon the final rule published in the August 7, 2019 federal register adjusted for the county CBSA wage adjustment. Rates subject to change if subsequent Correction Notice is issued.
